We'd like to take this time to **thank all of you for camping at Medcalf Acres Riverfront Campground.** It is with your help and your commitment to abide by our rules and regulations that make our campground one of the best campgrounds in the Adirondacks. We hope everyone is looking forward to a fantastic camping season! Check out our Website and Facebook to see all the new things we've added!

Enclosed with this letter you will find a copy of the **2019 Rules & Regulations**, which are yours to keep. Also enclosed are the 2019 Seasonal Camper Application, Rules & Regulations Acknowledgement, Storage Release of Liability, Swimming Facilities Rules, and Visitor's Acknowledgement of Risk that must be signed and returned to the campground store, (pages 19-23). It is important that you read and understand these items, so please take a moment to familiarize yourself with them. In order to confirm your site for the season, please complete and sign all forms in the application packet (pages 19-23) and return them to the campground store the first time you are back in the campground. Failure to return a signed copy of the rules and regulations signature pages for Warrensburg Travel Park prior to entry into the Campground for the 2019 season, constitutes your admission and acceptance that you have reviewed and accept these rules and regulations, even though you may not have signed these documents. Do not enter the campground unless you understand these rules and regulations. \*\*\* **(SEND BACK 5 SIGNATURE PAGES ONLY!)** \*\*\*

**If you can't follow the rules and regulations, then this is not the campground for you. If you do not follow these rules and regulations, you will be asked to immediately remove your RV from the campground and there will be no refund of your money. Safety & Security is of utmost importance!**

**Most of these rules are common sense things to help keep our campground safe and secure.** It is with no intention to insult anyone with any of these items. If you have any concerns, please let us know right away. Basic common courtesy and respect for each other is needed throughout the campground.

We value the opinions and suggestions of every customer, so please call or text Karl at 518-605-9247 with problems or concerns. Or share a good experience you've had, because we love to hear good news. Since Karl is busy running two campgrounds you probably won't catch him by chance, so we ask that you call or text him with any issues as they arise. He is very good at returning calls.

Please abide by all the rules and regulations listed here and use good common sense for the safety and common courtesy of your fellow campers. These rules and regulations are to help everyone get along! Most importantly use good judgement and have FUN! Note: The name Medcalf Acres is used in this document and short for Medcalf Acres Riverfront Campground.

## Rules & Regulations

**Quiet Time is from 11pm to 9am.** In keeping with the family environment, campers are asked to refrain from any loud behavior or disturbances during this period. **Children, age 17 and less, must be on their site and/or under direct adult supervision by 10 PM.**

**Store hours 9am-9pm (hours may vary).** Use the Walkie Talkie to call the Manager to open the store.

**Playground, Volleyball, Horseshoes and Basketball court:** Children should be supervised by an adult 18 and older! No horseplay, and no bullying. **Hours 9am-dusk** or management discretion.

**5 MPH Speed Limit / Vehicle Use:** For everyone's safety, the speed limit in the campground is 5 MPH or less! This includes cars, bikes and golf carts. Anyone exceeding this speed limit will be asked to leave Medcalf Acres, as we need to protect the children, pets and all campers.

**Backflow Restrictor for fresh water is a state law:** On each water spicket on your site is a brass backflow restrictor. These must be on your connection. The connection should be: your water hose, then backflow restrictor, then our spicket. The backflow restrictor keeps impurities from backing up into the campground water supply. There is a **\$100 fine** to you if you do not have a backflow restrictor on your connection at all times. This is per the Health Department! No exceptions! We do not need the Health Department on our bad side. If anyone has any questions, please call Karl immediately. Thank You!

**Campsite Accommodations:** Campsites are designed to accommodate no more than one camping unit at a time. A campsite may have a maximum of 6 people staying overnight on their site unless authorized by Karl. All campers' vehicles must be parked on their designated campsite.

**Management reserves to right to access your campsite for any reason what so ever at any time.**

**No parking your vehicles of any kind** on an empty site without Karl's permission. Empty sites are to remain open at all times!

**Picnic Tables:** Do not swap out newer picnic tables for your old picnic table without Karl's permission. If you swap out an old table and we don't know about it, there will be a broken table floating around and someone may get hurt. If you would like a newer picnic table, please ask permission. If you have a bad table, let us know right away. We provide one picnic table per site.

If you would like to purchase a **brand-new picnic table so you have 2 tables**, they are \$250.

**Never take anything** off anyone's site without their permission. If someone permanently leaves their site do not enter their site to take things without Karl's permission. Some things may have been sold or given away.

**Campfires:** No unattended fires ever! No exceptions! We don't want the campground burning down. Fires in fire rings or fireplaces only. Don't take someone else's firewood without permission. No glass of any kind

should be put in the fire pit under any circumstances. Any kind of accelerant to start fires are also strictly prohibited (lighter fluid OK). Read rules on website about bringing firewood in.

**No sparklers or fireworks! Never!**

**Fire Safety:** For safety, make sure your fireplace is not too close to trees, under wires or on top of pipes and wires. If you are not sure, call Karl. All trailers and awnings have to be at least 10 feet away from your neighbors' trailer, awning, gazebo, shed, tent and any structure of any kind per NYS Health Dept rules.

**Check In / Out:** Seasonal Campers may check into the campground for the season any time after 10:00 AM on opening day. All Seasonal Campers must vacate the campground by 5:00 PM on Columbus Day. Most transients check in after 12 noon and check out before 11am. All other transient campers may check with Management as to our check-in/out policies as it changes depending on other campers staying at Medcalf Acres. We want you to get the most out of your stay!

**Pets:** There is a limit of 2 pets per campsite. If you have more than 2 pets, please call Karl. All pets must be kept on a leash (no longer than 10') and under the control of the pet owner at all times. **Please dispose of all pet droppings immediately in the proper trash container.** Please **do not** tie up pets at the site and leave them unattended. **Pets cannot be left inside your trailer unattended at any time.** Pets are not permitted in any public buildings. Failure to follow pet policies is grounds for removal of the campground!

Owners are responsible for the actions of their pets. **The management reserves the right to refuse aggressive pets. Seasonal Campers are responsible for their friends and family's pets.**

**Pets that annoy other campers or are deemed a nuisance will be asked to leave the campground.** Medcalf Acres shall be held harmless and assumes no liability, implied or otherwise, for animal bites or injury. You, as a pet owner, specifically agree to carry your own insurance and agree to indemnify Medcalf Acres to cover any injury or damage, which may occur. Seasonal Guests must always have a copy of the pets shot records (including proof of rabies vaccination) with them when staying at Medcalf Acres.

Pets at your site still must be on a leash if outside your trailer at any time. No exceptions! This applies at all times no matter how many people are in the campground. No refunds if you are asked to leave for not following rules.

Dogs must be on a leash and secured at all times. (A pet with a leash attached and running loose does not meet the leash rule. Secure your pets!) Break-away collars or leashes are not allowed. Secure, sturdy pens need to be approved by Karl. The camper taking a dog for a walk must be able to control the pet. In other words, don't send the children out alone with your dog. It's best practice to prevent accidents, bites and dog fights.

**Improper Behavior:** For the protection and benefit of all campers and guests, anyone who willfully or negligently destroys or defaces the property of another camper or Medcalf Acres property will be held liable for the full value of replacement cost and may be subject to being asked to leave the campground permanently.

**No firearms and no weapons in the campground.** No B.B. guns, air guns, paintball guns, bow and arrows or slingshots. No large knives. No sparklers or fireworks. Further, any individual who violates these guidelines, or by their actions or words disturbs the peace, creates conflict, or otherwise creates a situation not in keeping with the family environment, may be instructed to leave the campground with no refund!

**Parental Responsibility:** Please provide proper supervision for your children while in the campground. All children must be under direct adult supervision. Children 17 years and less must have adult supervision while

in the Campground and at the pool and the river. Parents will be held responsible for the actions of their children.

**Alcohol Policy:** In keeping with the family environment, excessive use of alcoholic beverages is not tolerated. Violators will be requested to leave Medcalf Acres with someone else driving them.

**Guests:** Campers may have guests (people not registered on your seasonal site) visit them. They're FREE to visit! Campers are responsible for the behavior of their guests. Do not cut through other campers' sites without permission! Guests are permitted to bring friendly pets into the campground with proof of rabies vaccination. This must be carried with them at all times. No exceptions! Aggressive pets will be asked to leave.

### **Campground Guests**

While 95% of the time there is no charge for guests of seasonal campers to visit, and that policy remains, we are now requiring guests to sign in at the store, pick up a rules and regulations packet.

**Family, Friends, and Visitor Policy:** **Tents** are allowed on your RV site for minors, 17 years of age or younger, at no extra charge. **Kids are always FREE. \$10 per night for adults 18 and older.**

**Visitors staying with a seasonal camper** in a tent or **sleeping anyplace outside your RV, age 18 or older**, who are not part of the original family that signed up to be seasonal, **must pay the campground store \$10 per person / per night.** Please pay in advance. **There is no charge for family and friends staying in your RV while you are there** (maximum of 6 adults).

**Subletting your RV** (when you're not there) is permitted but must be approved by Karl (give him a call). If you sublet your RV to someone, not part of the original family that signed up to be seasonal, then those **age 18 or older must pay the campground store \$10 per person / per night.** Please pay in advance.

**Decks, Storage Buildings & General Construction:** No construction of any kind is permitted without written permission from Karl. Built-on shelters, wooden shelters, stick-built (wooden) patio rooms, and fencing around campsite areas are not allowed without permission from Karl. (Call him).

If any work is completed by an outside contractor, the contractor must be a licensed contractor with an insurance binder. Proof of insurance along with the insurance binder must be provided to Karl before work can begin. Compliance with local zoning regulations and municipal permits are the responsibility of the camper and must be shown to Karl.

**Using Medcalf's Stone and Dirt Piles is not part of your seasonal fee.** No one is allowed to take anything off the stone piles or dirt piles unless they have Karl's permission. (Call him). Large quantities will need to be purchased by campers.

**Sheds** must be constructed no more than one per site, and no larger than 6x8. All sheds must receive approval from Karl prior to placement on your site. They must be kept in good repair.

**Decks** must be kept as low to ground as possible. All decks will require a sketch prior to building indicating material used, overall size of deck, size of sections, framing, name of customer, site number and date to be built. A removable 8x24 pressure treated platform is permitted for the ground outside of your RV; it must be in no larger than 4x8 sections. Decks may not be anchored in the ground; they must be sitting on floating blocks. All decks shall be constructed with treated lumber only (no plywood). Decks should not be constructed so close to trailers that we would not be able to move trailer in an emergency, such as underground repairs, falling trees, etc. It is the responsibility of the customer to remove and reinstall the deck as necessary.

**Anyone moving to a different site may incur an additional fee based upon our pricing. Better sites cost more.**

**All decks must be removed when leaving** the campground or burned. It is not our responsibility do get rid of your deck. All sites must be cleaned when you leave your seasonal site and you are not returning to Medcalf Acres. There will be a fee of \$200 billed to you if your site is not clean when you leave. Wood does not go near or in the dumpster.

**Sewer / Septic Requirements:** Please **FLUSH ONLY TOILET PAPER! No wipes, paper towels, rags, feminine sanitary products, diapers, etc as these harm our sewer system.** Any permitted deck or screen house **must have access to septic connection.** A **sewer donut** is required around your sewer hose at the point of connection to the sewer pipe. If you do not have one of these, we will arrange for installation and charge you accordingly. Your sewer hose must be sloped downward from your trailer's septic connection to the campground sewer hookup to prevent any clogging or spillage on the ground. **If your sewer is working fine, no problem, leave it be!**

**Golf Carts:** All persons driving a golf cart need to have a valid Driver's License (NOT a permit). Only licensed drivers from the site, given permission, may drive your golf cart. No exceptions! All carts need to have fixed headlights and tail lights. **Site numbers must be clearly displayed** on both sides of your cart in 3" or larger numbers/letters. Don't overload your golf cart with passengers.

Golf carts are to be operated in a safe and reasonable manner at all times. Please stay on common roads at all times and abide by all posted speed limits. All golf carts must be maintained in good working order. Management reserves the right to refuse registration to carts that are deemed unsafe and unpleasant to look at per Karl keeping the Campground looking good. **Do not drive your golf cart under the influence of alcohol or drugs. No open containers on golf carts.**

**Charging of golf carts** is limited to your own site only. Violation of these rules will result in fees and/or suspension of golf cart privileges. There is a **\$100 charge** for having an electric golf cart at Medcalf Acres to offset electric costs to charge the batteries to operate the golf cart. **Gas are free!**

You must carry **golf cart insurance** and it must be approved by Karl as to limits of liability, property damage, etc. and insurer shall notify Karl at all times of non-insurance because of cancellation. Medcalf Acres must be added as an additional insured. Insurance cards are to be provided to the campground store yearly when camp opens. **You cannot drive your golf cart in the campground without insurance, no exceptions!** Please follow the rules and laws of NYS drinking and driving as they apply to Golf Carts also. **Driving while intoxicated (DWI) is against the law! Driving while ability impaired (DWA) is illegal! Don't go to jail!** Please follow the rules of NYS of drinking and driving as they apply to Golf Carts also. **Driving while intoxicated is against the law!**

**Electricity:** Please help conserve electricity. Turn off all lights when leaving your site for an extended period. This includes inside and outside lights, fans and A/C. No excessive decorative lights should be hanging outside your trailer. **You can have two strings of LED lights, 20' long.** All extra exterior lighting must be approved by Karl (give him a call). Keep your seasonal rates down, **conserve energy! You will be charged if you have too many outside lights, or if you leave your light on.**

**More Lights** - Please remember to turn off your outside lights at your site, on your RV, under your awnings, etc. during the day and when you go to sleep. Some of your lights are very bright and are blinding your neighbors at night. We all need a good night's sleep.

**Extra Refrigerator / Appliance Policy:** Please pay your invoice for an extra appliance! A large frig is \$100 extra, medium frig is \$75, small frig is \$50 / year. This fee for extra electricity is due on or before April 1. **Failure to pay will result in doubling the fee or possible removal from the campground.**

**Neatness Policy:** Campsites and decks **must be kept NEAT.** Decks are NOT to be used as storage areas. Campers are responsible for keeping their site area clean and **free of debris.** Sites deemed by the Management to be in violation of this policy will be subject to a fine and or removal from the campground. Do not store wood other than firewood. **Keep the Campground clean!**

**Tree Policy:** It is the policy of Medcalf Acres to leave the campground in its natural state whenever possible. If a wooded site is chosen, it is understood that the trees are part of the landscape and beauty of the area.

If you wish a tree to be removed, the following procedure must be followed 1) Call Karl 2) Karl will assess the situation and allow or disallow its removal. If it is ascertained that the tree must indeed be removed, we will take one of the following two actions: If our staff is able to safely remove it, we will proceed accordingly. As a courtesy, the site occupant will not be charged for the removal of the tree. If our staff is not able to safely remove it, we will secure bids from authorized tree removal specialists. We will schedule the removal of the tree with the company chosen and the campsite occupant will be charged accordingly. If a tree requires removal and/or trimming due to disease or storm damage, the site occupant will not be charged. Under no circumstances should you remove the tree yourself or hire someone else to remove it. Any and all tree removal must be pre-approved by Karl. (Call him). **No chainsaws** or cutting of trees.

**Landscaping:** Seasonal campers will be responsible for the upkeep and maintenance of their site including mowing, trimming, and weed removal. Seasonal campers are required to rake all leaves and general debris from their site. If you are not able to perform these duties due to physical limitations, please contact Karl to make other arrangements. **All leaves and pine needles must be disposed of by you in the woods behind Site 60a as far back in the woods as possible! Do not leave piles of leaves and pine needles on the side of the roadways. We do not pick them up!**

**Parking Policy:** Please park all vehicles on your own site or other pre-approved areas. You may not park on anyone else's seasonal site or non-seasonal sites at any time, regardless of current occupancy. No exceptions. For **additional parking for guest or other vehicles not able to fit on your site**, see Manager.

**Trash Disposal:** Garbage is **not picked up** at individual campsites. Please dispose of all trash in the dumpster provided behind the store. Do not dispose of hazardous materials or bulk items in trash containers. **No tires or oil!** Do not bring trash from home or burn trash at your campsite. Trash cans at the bath houses are for loose trash only, not bagged trash. Campers found to be disposing of garbage inappropriately may be subject to fines.

**If you have large bulk items** we will take them to the town dump for a fee. Please call Karl to make arrangements for removal and disposal of bulk items. Any fee quoted for hauling must be paid in advance of removal. Do not throw big items in front of the dumpster!.

Please put all **recyclables in the zero-sort recyclable dumpster**; recyclable bottles, cans, cardboard, etc. **Please leave 5 cent deposit bottles and can** in the designated garbage can by the dumpster if you do not want them.

**No Urinating in public** - If we see, or it is reported to us that you were seen urinating behind a tree or vehicle or your camper you will be asked to leave the campground. Just about every single site here has campers on all sides so there is no reason to think we can urinate behind a tree or vehicle and not be seen. There will be no excuses! Get caught ONCE, you will be asked to leave. It is also against the law; Public lewdness! There will be no exterior bathrooms allowed on your, this is very unsanitary and causes odor problems.

**No Drunk Driving** - Drinking and driving in the campground will not be tolerated. This includes golf carts and motor vehicles. If we see you with open containers in your vehicle and /or with someone intoxicated behind

the wheel, you could be leaving the campground for good. **No open containers allowed on golf carts at any time. Report drinking and driving to the State Police by calling 911.**

**Washing Campers/Vehicles:** Units that remain year-round **must be** washed at least once a year. Personal automobiles cannot be washed in the campground at any time.

**Clotheslines:** There have been accidents where kids have been running through sites and have been seriously hurt from a clothesline. **All clotheslines must be at least 7' high.**

**Swimming in the River:** All campers must abide by the rules and regulations posted by the main beach. There are no lifeguards on duty and swimming is at your own risk. No one should ever swim alone. Please see the 'Use of our Swimming Facilities Rules' for more complete information. Bathing yourself in the river is not permitted at any time. **There must be 2 adults 18 and over at the beach to swim, at all times!**

**Life jackets must be worn by all children under 12 years of age on any boat less than 65 feet and must be available for everyone on board. This includes kayaks, canoes, tubing, etc.**

**No parking, beaching or docking** of kayaks, canoes or boats on our beach for extended periods of time.

**Swimming Pool Safety and Cleanliness:** The swimming pool will open and closed for the year at owner's discretion depending on the weather, typically **Memorial Day Weekend through Labor Day Weekend.** No diving, no flips, no peeing in pool, no running, no horseplay, no glass items, no sharp items, no floats, no tubes, no eating, etc. in the pool area. The only pool floats or toys that are allowed in the campground pool are noodles, children's arm bands / swimmies, baby and toddler personal floats. No balls, no squirt toys, no large floats, no food, no remote-control toys. A blow-up beach ball is ok.

**Swim Diapers:** Babies and children who are not potty trained must wear swim diapers.

**No Nudity:** Everyone must wear a swimsuit or clothing in the pool or river.

Pool will be open 10am-8pm, from Memorial Day to Labor Day. No more than 40 people in the pool at any time. No smoking. The pool closes immediately due thunder or lightning. Please exit pool immediately if asked to do so!

**Pool Guests:** We do not allow non-paying guests to be in the pool. If you have guests who want to use the pool, you must accompany them. We reserve the right to limit the number of guests that seasonal campers bring to the pool. Guests are required to sign in at the office and adhere to all campground rules and regulations.

**Fishing:** You must have a NY State license to fish if you are 16 years of age or older. You must follow all fishing rules and regulations as per the DEC and the State of New York. You may catch and eat your fish as long as you abide by the state's rules. Licenses may be purchased at Walmart and other fishing stores. **No fishing in swimming areas.**

**Selling Your Camper:** Management shall be notified prior to the sale (or proposed sale) of a camping unit in Medcalf Acres. Management approval is required for the unit to remain at the campground. This includes the right to review the qualifications of any prospective buyer, the condition & age of the camping unit, site & deck or screen house. New seasonal may have a higher price.

Any conditions not met at time of transfer become the responsibility of the buyer. Please use the Bulletin Board to help you sell! Medcalf Acres will not prorate any portion of your unused seasonal fees.

- In consideration of Medcalf Acres granting of the non-exclusive use of the storage area, seasonal camper hereby agrees to hold Medcalf Acres, its officers, directors, partners, agents and employees harmless from, and hereby releases any claim he or she may have against Medcalf Acres, as the result of any damage (including, without limitations, theft, vandalism, malicious mischief, fire, hail, flooding or windstorm damage) to Resident's property arising from or occurring while it is stored or moved in or at the campground pursuant to this Agreement regardless of whether such loss or damage may have been caused or contributed to in full or in part by an act, error or omission of MEDCALF ACRES or its officers, directors, partners, agents, employees. **Camper further agrees to maintain personal property, flood and liability insurance on all units stored at the campground pursuant to this Agreement.**
